ITEM

Switching charges named herein (unless otherwise specified) will apply for the handling of loaded cars one direction and empty cars in the reverse direction. If cars are moved empty in both directions, then charges for a one-way movement will apply. If cars are moved empty in one direction and are not returned, they will be charged as if they were loaded and switching of other cars loaded will not be considered as offsetting one-way movement of empty cars. If cars are loaded in both directions, the applicable charge will be assessed for each loaded movement.

DEFINITIONS

- (a) Intra-Plant Switching - A switching movement of cars, loaded or empty, from one track to another track or between two points on the same track, within the same plant or industry without leaving the tracks of the same plant or industry.
- (b) Intra-Terminal Switching - A switching movement (other than intra-plant switching) from one track to another track of the same carrier, within the switching limits of one station or industrial switching district.
- (c) Inter-Terminal Switching - A switching movement from a track of one carrier to a track of another carrier when both tracks and movement are within the switching limits of the same station or industrial switching district.
- (d) Reciprocal Switching - A switching movement from a plant or industry located on the AGR to the point of interchange with connecting carriers or vice versa, on line haul traffic.
- (e) Intermediate Switching – A switching movement of cars from the interchange tracks of one connecting carrier to the interchange tracks of another connecting carrier within the switching limits of the same station on which the switch carrier neither originates nor terminates the shipment nor receives a line-haul. Empty car movements as defined above, that move between AGR stations to and from connecting carriers will also apply.

**ASSIGNED CARS:** The assignment of cars to a given shipper at a specific location as defined in Car Service Rule 16 and Car Hire Rule 22.

**CHARGEABLE DAY:** A twenty-four (24) hour period, or fraction thereof.

**CONSIGNEE:** The party designated on the bill of lading as the entity entitled to receive delivery of the goods from the carrier.

**CONSIGNOR:** The party designated on the bill of lading as the entity, which has caused the goods to be consigned into transportation.

**CONSTRUCTIVE PLACEMENT:** When a car, including order notify and in-bond shipments, cannot be actually placed because of any condition attributable to the loader or unloader, such car will be held on AGR tracks and notice will be given to the loader or unloader, that the car is held awaiting disposition instructions. Such cars which have been placed by AGR on private or other than public delivery tracks, including lead tracks serving the loader or unloader, will be considered constructively placed without notice.

**CREDIT:** A non-chargeable demurrage day. A maximum of 1 excess credit is to be applied per car per movement. An excess credit is when the car is placed for loading or unloading and is loaded or unloaded on or before 11:59 P.M. of the day the car is placed.

**DEBIT:** A chargeable demurrage day.

**DEMURRAGE DAY:** A twenty-four (24) hour period, or fraction thereof.

**DISPOSITION:** Information, including forwarding instructions or release, which allows the railroad to either tender or release the car from the consignor's or consignee's account.

The through rate to apply is the applicable rate (local rate, joint rate or combination of intermediate rates) in effect on the date of shipment from point of origin over the route of movement via the diversion or reconsignment point to final destination; or, the rate to be applied will be the rate from point of origin through diversion or reconsignment point to ultimate destination.

No backhaul is permitted in connection with these rules. If the backhaul results as a consequence of a diversion order, combination rate will be applied.

Cars stopped or held for diversion or reconsignment under these rules also will be subject to demurrage and track storage charges lawfully in effect at the points where such stopping or holding is accomplished, except no free time will be allowed.

All applicable switching charges, including charges to and from hold tracks, necessitated by the diversion or reconsignment will be assessed by the AGR. The AGR will assess a charge of \$158.00 per car when it has no published switching charge for a switching service, which it performs in the necessary movement of a diverted or reconsigned car.

A diversion or reconsignment charge of \$53.00 per car will be assessed for each car diverted or reconsigned under the provisions of this item.
