ADDENDUM 1

Dangerous Goods/Hazardous Materials Surcharge:

Carload commodities of Dangerous Goods/Hazardous Materials (STCC 49 or 29 Series) being hauled or switched on the CBNS will be subject to a surcharge of \$245 per car in addition to all other applicable charges.

Inspection of Hazardous Material Cars on Railroad Property

When a hazardous material car is held in the yard at the request of the customer exceeding five (5) calendar days, the cars must be inspected every forty-eight (48) hours as required by Canadian Law. The customer will be assessed a charge of \$40 per car, per inspection. These charges will be assessed on a monthly basis.

Handling of Empty Freight Cars

*This provision will not apply when the empty movement is immediately preceded by a loaded revenue movement on **CBNS** and empty is returned to original interchange or if the empty movement is immediately followed by a loaded revenue movement on **CBNS**.*

This provision applies on all types of rail cars, including, but not limited to, cars provided by railroads, leased cars and cars bearing other than railroad reporting marks, but not including passenger train cars.

The charge for movement of empty cars is \$2.00 per mile, subject to a minimum of 150 miles. **CBNS** will not be responsible for the payment of any per diem or mileage charges, nor will **CBNS** absorb any switch charges. This rate will apply only to movement of cars in regularly scheduled train service.

If special train service is required for movements other than those listed above, charges contained in the Charge Schedule on page 2 of this Catalog will apply.

Rates are subject to the CBNS 9002 Fuel Surcharge Tariff.

CBNS's maximum liability for loss and damage is \$100.00 per railcar.
