Each shipment hereunder shall be tendered to Carriers on a Uniform Straight Bill of Lading. CFE Quote number must be shown on all bills of lading tendered for shipment.

Except when specifically provided herein, rates do not include switching charges at origin or destination.

Shipments shall be billed accounting rule 11.

FORCE MAJEURE

If a party is unable to meet its obligations hereunder as a result of an Act of God, the public enemy, authority of law, fire, explosion, strike, lockout, war, insurrection, derailment, damage to or shortage of equipment, or other like cause beyond reasonable control of the party, then the parties obligations shall be excused to the extent prevented by such force majeure, provided, however, the party declaring force majeure shall notify the other parties promptly after learning of such force majeure's existence, and after its cessation.
