GENERAL RULES:

Not subject to Rule 24 of tariff STB-UFC-6000 Series. This rate authority may be cancelled upon 20 days notice by either participating party.

Except when in conflict with the other provision of this Letter Quote, shipments of Commodity(ies) tendered for transportation hereunder shall be governed by tariffs, exempt circulars, rules, regulations, classifications, that would govern the rights and obligations of the parties if this Letter Quote did not exist, except that no diversion, reconsignment or transit privileges will be permitted. Rate will apply on rejected shipments moving back to original destination via reverse route.

Each shipment hereunder shall be tendered to Carriers on a Uniform Straight Bill of Lading. KYLE Quote number must be shown on all bills of lading tendered for shipment.

Except when specifically provided herein, rates do not include switching charges at origin or destination.

Shipments shall be billed Accounting rule 11.

FORCE MAJEURE

If a party is unable to meet its obligations hereunder as a result of an Act of God, the public enemy, authority of law, fire, explosion, strike, lockout, war, insurrection, derailment, damage to or shortage of equipment, or other like cause beyond reasonable control of the party, then the parties obligations shall be excused to the extent prevented by such force majeure, provided, however, the party declaring force majeure shall notify the other parties promptly after learning of such force majeure's existence, and after its cessation.

LOSS OR DAMAGE

No claim for physical loss or damage to any one shipment transported hereunder shall be made or filed by Customer for amounts of \$250.00 or less. Any claims should be filed with the destination Carrier.
