Except when specifically provided herein, rates do not include switching charges at origin or destination. Shipments shall be billed Accounting Rule 11.

**LOSS OR DAMAGE**

No claim for physical loss or damage to any one shipment transported hereunder shall be made or filed by Customer for amounts of \$250.00 or less. Any claims should be filed with the destination Carrier.

**FUEL SURCHARGE**
