ADDENDUM 1 TPW

Intermediate Switch

TPW acts as a switch carrier moving cars between two other carriers at an interchange point.

Rates do not apply on dimensional shipments.

An additional \$1000.00 will be assessed to the rates below for all **TIH/PIH** commodities.

•Rates do not apply on intermodal equipment.

HANDLING OF EMPTY FREIGHT CARS

This provision will not apply when the empty movement is immediately preceded by a loaded revenue movement on TPW and empty is returned to original interchange or if the empty movement is immediately followed by a loaded revenue movement on TPW.

This provision applies on all types of rail cars, including, but not limited to, cars provided by railroads, leased cars and cars bearing other than railroad reporting marks, but not including passenger train cars.

The charge for movement of empty cars is \$2.00 per mile, subject to a minimum of 150 miles. TPW will not be responsible for the payment of any per diem or mileage charges, nor will TPW absorb any switch charges. This rate will apply only to movement of cars in regularly schedule train service, or to movement of not less than 25 cars shipped in one day, on one bill of lading, to one destination.

If special train service is required for movements other than those listed above, special train charges in the charge schedule of page 2 of this catalog will apply.

TPW's maximum liability for loss and damage is **\$100.00 per railcar**.
